Perform Points add up quickly in heavy and medium weighted activities.

Report up to 4 total medium and high weighted activities. At the least, report 2 for 90 days. Medium activities are worth 10 points and high are worth 20 points.

Submission will be done electronically by athenahealth.

10% points bonus for 1 eligible Improvement Activity (IA) reported using CEHRT.

What activities will athenahealth support?

Out of the 93 finalized activities for CY 2017, athenahealth will initially support 11 activities (see Table 1) at the start of the reporting period (1/1/2017). These activities can be supported through CEHRT and cover Population Management, Patient Safety & Practice Assessment, Behavioral & Mental Health, and Beneficiary Engagement. Additional activities will be added in 2017 to ensure coverage for all MIPS eligible clinicians using athenaOne.

Which activities will eligible clinicians (ECs) be enrolled in at the start of the year?

Clinicians will be enrolled in an initial set of Improvement Activities focused on appropriate screenings, shared-decision making, transitions of care, and medication reconciliation. Measure satisfaction is built into workflows to demonstrate participation, giving credit for the activities you're already doing as part of normal workflows and satisfying CMS reporting requirements for this performance category.

How do I request the activities I want?

You don't have to! On January 1, 2017, all eligible clinicians (ECs)* will get automatically enrolled in an initial set of activities that are already part of encounter workflows and athenaOne capabilities that will maximize your performance and set you up for success.

What attribution model will be used?

Similar to other government programs, patients will be attributed to any provider who supervised care for at least 1 encounter. This means that a single patient may fall into the denominator for more than one eligible clinician.

How will athenahealth demonstrate Improvement Activity satisfaction?

By automatically enrolling providers in an initial set of activities, athenahealth will be able to track and accurately determine when providers meet 90-days of continuous enrollment. Activities will be satisfied when 1 patient meets criteria for numerator completion.

Where do I find the performance benchmarks for these activities?

There are no performance benchmarks in the Improvement Activities category during the 2017 transition year. Performance in this category will be tracked by athenahealth and attestation of activity satisfaction will be completed by us on your behalf. In future years, performance will be tracked and made public by CMS.

How is data reported to CMS?

IA can be reported as either an individual EC or Group. Reporting style must be consistent across all 3 categories (Quality, ACI, and IA). athenahealth is certified to electronically submit data as both a registry and EHR vendor. Thus, we support measures that are available for Registry reporting, EHR reporting, or both.
